ALIDA TCHICAMBOUD



The Interchurch Center spotlights Alida Tchicamboud, MA, Founder and CEO of Healing Hands Incorporated — a survivor-led, culturally specific nonprofit dedicated to ending sexual commercial exploitation, domestic violence, and gender-based violence. Healing Hands provides trauma-informed support that helps survivors—especially within Black communities in New York City—rebuild their lives with strength and dignity.

About Healing Hands

Founded in 2016, Healing Hands Incorporated is a survivor-led organization committed to ending exploitation and violence through awareness, empowerment, and culturally specific care. Their work focuses on breaking cycles of silence and injustice impacting Black survivors and communities of color across New York City.

Healing Hands offers trauma-informed counseling, economic empowerment, housing support, and survivor-leadership development. Their multilingual team—speaking more than ten languages—brings deep training in trauma-informed and culturally specific practices, creating a safe community where survivors can heal and thrive.

Spotlight on Alida Tchicamboud

Alida Tchicamboud is a survivor, advocate, and visionary leader whose lived experience fuels her mission to uplift those impacted by exploitation and violence. She also leads Tchic Consulting, a trauma-informed HR firm addressing sexual assault, domestic violence, and commercial sexual exploitation within workplace systems. Fluent in English, French, Lingala, and Kikongo, Alida connects across diverse communities to advance survivor-centered, culturally grounded practices.

Her commitment ensures no survivor must choose between silence and survival. Through her leadership, she champions healing, justice, and community accountability—creating pathways for survivors to rebuild their lives with dignity, hope, and support.





TIPS & TRICKS FOR NON-PROFITS

YEAR-END STRATEGY: CONDUCT A MINI SWOT TO STRENGTHEN YOUR 2026 IMPACT

As nonprofits close out the year, many are juggling budget gaps, shifting community needs, and uncertainties around government funding cycles. December is the ideal moment to pause and evaluate where your organization stands, before new initiatives, grant cycles, and programs launch in January.

A simple Mini SWOT Analysis (Strengths, Weaknesses, Opportunities, Threats) can help nonprofits gain clarity in just 30 minutes. This quick assessment becomes a powerful tool for prioritizing resources, improving decision-making, and preparing for a stronger 2026.

Here's how nonprofits can leverage a Mini SWOT effectively:

- 1. Identify your top 3 strengths.
- 2. What worked well this year? Consider community partnerships, volunteer engagement, board involvement, or a successful program that exceeded targets.
- 3. Be honest about internal weaknesses.
- 4. Where did your team struggle? This could include inconsistent communication, staffing gaps, outdated tech, or donor follow-up delays.
- 5. Spot emerging opportunities for 2026.
- 6. Look at trends: corporate volunteerism is rising, new grant categories are opening, and collaboration between organizations is increasing citywide.
- 7. Acknowledge external threats.
- 8. Funding delays, workforce shortages, rising program costs, and policy changes can impact your ability to deliver services.

Why This Matters Now

Finishing the year with a clear picture of your organization's position helps you.

- Refine your 2026 goals
- Strengthen grant applications
- Improve board presentations
- Make more informed budgeting decisions
- Build strategic alignment with staff and partners
