

TIPS & TRICKS FOR NON-PROFITS

NAVIGATE NYC'S PAYMENT-DELAY CRISIS AND STRENGTHEN **FINANCIAL RESILIENCE**

Across New York City, nonprofits are doing more with less, meeting rising community needs while grappling with major funding disruptions. A new report from the Nonprofit Finance Fund reveals that 32% of NYC nonprofits receiving government funding were paid 90 or more days late, compared to just 10% nationally. These severe delays are leaving many organizations struggling to make payroll, cover rent, and maintain essential programs.

The ripple effects are widespread. Organizations are being forced to take on debt, delay vendor payments, and reduce staff hours, all while community needs continue to grow. For many, this has become a structural issue, not just a short-term inconvenience. The challenge underscores an urgent truth: liquidity and proactive communication are mission-critical. Here are four ways NYC nonprofits can respond effectively:

- 1. Build a cash-flow cushion
- 2. Assess funding vulnerabilities.
- 3. Diversify your revenue mix.
- 4. Communicate transparently.

Finally, treat this as a moment for collective advocacy. Join local coalitions such as the Human Services Council (HSC) or Nonprofit New York, which are calling for faster government payment reform. Collective voices make system-level change possible.
